To either of the Constables of Warwick. GREETINGS:

In the name of the Commonwealth, you are hereby required to notify and warn the inhabitants of said Town who are qualified to vote in elections and in Town affairs, to

MEET AT THE TOWN HALL ON MONDAY, October 23, 2017, AT 7:00 P.M.

Then and there to act on the following articles:

ARTICLE 1: Shall the Town amend the May 1, 2017 Annual Town Meeting vote in Article 12 on the FD brush/ rescue truck by reducing the appropriation to \$45,000. Or take any action thereon?

ARTICLE 2: Shall the Town adopt a general by-law that prohibits feeding Canada Geese on or around Moores Pond; enforced by the Selectboard; punishable by a fine payable to the town clerk of \$25 for the first offense, \$50 for the second; \$100 for third and subsequent offenses; or take any other action thereon?

ARTICLE 3: Shall the Town establish an Environmental Cleanup Fund and raise and appropriate \$10,000 to fund disposal of illegal dumping and other environmental cleanup on properties the Town has taken for taxes or the owner is absent, under the control of the Selectboard or take any other action thereon?

ARTICLE 4: Shall the Town, raise and appropriate \$1,000 to the Transfer Station Enterprise Fund for disposal cost of illegal dumping in road right of way or town land, or take any other action thereon?

ARTICLE 5: Shall the Town, pursuant to MGL Chapter 40, section 3, authorize the Selectboard to purchase real estate abutting the Wendell Road Town Forest, or take any other action thereon?

ARTICLE 6: Shall the Town raise and appropriate a sum of money for prior fiscal year unpaid bills, or take any other action thereon?

ARTICLE 7: Shall the Town enact a town-wide ban on the use of the herbicide class 2-4-D / Roundup, or take any other action thereon?
